A Guide to your CPD Membership

What is CPD?

Continuing Professional Development (CPD) involves intentionally developing your knowledge and skills to ensure you keep up to date and complete your professional responsibilities to the highest standard. Across the UK workforce, CPD is expected of most individual professionals in most sectors.

CPD is generally governed by sector-specific professional bodies or regulators. Employers also increasingly expect their staff to undertake CPD, and may even measure them on it. However, it can also be undertaken independently by professionals who don't belong to an institute for personal career development.

CPD activities can range from formal educational activities such as instructor-led training courses, through to work based



learning such as mentoring, or self-directed learning such as e: learning courses or structured reading.

Who are the CPD Standards Office?

The CPD Standards Office is part of the Professional Development Consortium. By working with providers to enable positive and successful CPD activities, our mission is to raise the standard of CPD.

Our community is formed of a growing number of training providers, employers, universities, professional bodies, institutes and regulators. We offer an independent accreditation based on research that assesses and accredits training and individual coaches and speakers for Professional Development purposes.

When a training activity has been accredited, formal CPD points may be issued to the delegates upon completion for them to record in their CPD records. This applies particularly to regulated sectors such as Finance, Construction, Engineering and Medical.

The criteria, methodology and processes used daily by the CPD Standards Office to assess and accredit training activities are overseen by an independent panel of experts, drawn from academics, employers and professional bodies.

The Expert Advisory Board provides the CPD Standards Office with a rich and diverse range of expertise and ensures that our accreditation is authoritative.



How does your Membership work?

Working with the CPD Standards Office, provides a variety of benefits for your organisation from improving your sales, to building your reputation, and to joining our CPD community and connecting with key organisations in your sector.

Being a member of the CPDSO means you have registered training activities accredited, these can be events, workshops, training courses, online activities or individual coaches and speakers.
